ORDER SETTING TIME FOR RESPONSES

On January 7, 2020, Union Electric Company d/b/a Ameren Missouri and the Staff of the Missouri Public Service Commission filed a nonunanimous stipulation and agreement addressing the calculation of the rebasing adjustment for the Missouri Energy Efficiency Investment Act (MEEIA) Rider Energy Efficiency Investment Charge (EEIC). On that same date, Ameren Missouri also submitted a request for a waiver of 20 CSR 4240-20.093(4)(B) requiring the Commission to make a decision to either approve, modify, or reject these tariffs within 60 days of the tariff filing (January 21, 2020).

Commission rule 20 CSR 4240-2.115(2)(B) and (2)(C) allows each party seven days to file an objection and if no objection is timely filed, the agreement may be treated as unanimous. The Commission will describe the time for responses to the nonunanimous stipulation and agreement.

Additionally, Commission rules also generally give parties 10 days to respond to motions. However, in order to give the Commission sufficient time to consider the request for waiver, the Commission will shorten the time for responses to the request for waiver as set out below.

THE COMMISSION ORDERS THAT:

1. Any response or objection to the Request for Waiver shall be filed no later than January 13, 2020, at 10:00 a.m.
2. Any objection to the Initial Stipulation and Agreement shall be filed no later than January 14, 2020.
3. This order shall be effective when issued.
