# ORDER CANCELING PREHEARING CONFERENCE DUE TO RETURNED MAIL

Issue Date: January 10, 2020 Effective Date: January 10, 2020 The Commission has scheduled a prehearing conference to occur on January 15, 2020, regarding Unice Harris's complaint against Kansas City Power & Light Company.<sup>1</sup> On January 10, 2020, the order scheduling the prehearing conference, which had been sent to Ms. Harris by certified mail, was returned by the Post Office, marked unclaimed and unable to forward.
