### ORDER DIRECTING FILING OF STAFF RECOMMENDATION

Issue Date: January 10, 2020 Effective Date: January 10, 2020

On January 6, 2020,<sup>1</sup> Spire Missouri filed a response to Staff's motion to open a docket and suspend Tariff No. JG-2020-0105. Spire Missouri's response states it will extend the effective date of its tariff to February 21, and asks the Commission to give Staff until February 7, to file a recommendation. On January 8, Spire filed a substitute tariff with a February 21, effective date. Staff filed a response on January 9, again asking the Commission to issue an order to open a docket and asking that Staff be ordered to file a recommendation or status update by February 7.<sup>2</sup>

There is no need for the Commission to issue an order to open a docket, as this file was already opened by Staff's pleading asking that the tariff be suspended, as provided in Commission rule 20 CSR 4240-2.065(3). The Commission will direct its Staff to review and file a recommendation or status report regarding Spire Missouri's substitute tariff.
