On November 22, 2019, George L. Eliceiri filed a complaint against Missouri-American Water Company. On November 25, 2019, the Commission issued an Order Giving Notice of Contested Case and Directing Answer. On December 26, 2019, Missouri-American filed a Motion to Dismiss and Suggestions in Support. Dr. Eliceiri filed a Response to Missouri-American's Answer and Motion to Dismiss on January 7, 2020. On January 10, 2020, the Commission's Staff filed a Memorandum describing the results of its investigation.

The Commission will schedule a conference to discuss the schedule and procedures needed to resolve Dr. Eliceiri's complaint. All parties must appear, either in person or by telephone.
