ORDER RE-SETTING PREHEARING CONFERENCE

Issue Date: January 14, 2020 Effective Date: January 14, 2020

On September 18, 2019, Unice Harris filed a complaint against Kansas City Power & Light Company. Thereafter, the Commission ordered its Staff to investigate and file a report. Staff filed its report on November 4, 2019.

On November 18, 2019, the Commission scheduled a prehearing conference for November 26, 2019. Ms. Harris did not appear. The Commission excused her absence due to the short notice given in its Order and the fact that the prehearing conference was scheduled the same week as the Thanksgiving holiday.

The Commission re-scheduled the prehearing conference to occur on January 15, 2020. On January 10, 2020, the scheduling order which had been sent to Ms. Harris by certified mail was returned by the Post Office, marked unclaimed and unable to forward. In a conversation with Counsel for Staff, Ms. Harris stated she also had not received the emailed scheduling order. As sufficient notice to Ms. Harris could not have

been communicated between the time after the Order was returned and the scheduled prehearing conference, the Commission canceled the January 15, 2020, prehearing conference.

In order to discuss a procedural schedule and *possible settlement or mediation* of this matter, the Commission will reschedule a prehearing conference. For their convenience, the parties may appear by telephone as set out below.

THE COMMISSION ORDERS THAT:

- 1. The parties shall appear at a prehearing conference to be held on January 29, 2020, at 12:00 noon. Failure to appear at the conference without being excused may result in dismissal of the complaint in accordance with Commission rule 20 CSR 4240-2.090(5).
- 2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs an accommodation to participate in the conference or hearing shall contact the Commission, not later than the day before the conference.
