On November 15, 2019, the Manager of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission filed a complaint against Charles W. Brune and Anna G. Brune d/b/a Brune Mobile Sales (Respondents). On November 18, 2019, the Commission issued a Notice of Contested Case and Order Directing Filings. On December 18, 2019, Respondents filed an Answer. On December 19, 2019, the Commission scheduled a procedural conference for January 14, 2020, at 10 a.m., at the Commission’s office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The Order required all parties to appear. On January 14, 2020, as scheduled and ordered, the Commission took up the case for a procedural conference, went on the record and ordered the parties to enter their appearance on the record. The Complainant appeared by counsel. The Respondents did not appear. The Commission will order Respondents to explain why they did not appear.

**THE COMMISSION ORDERS THAT:**

1. No later than January 21, 2020, the Respondents shall file an explanation concerning why they did not appear at the procedural conference scheduled for January 14, 2020.
3. This order shall be effective when issued.


