**NOTICE ACKNOWLEDGING ISSUE TO BE CARRIED FORWARD**

Issue Date: January 8, 2025

On November 1, 2024, Evergy Metro, Inc. and Evergy Missouri West, Inc. (together, “Evergy”) filed a *Notice of Adding New SPP Charge Types* (Notice). The Notice, by rule, was filed in Evergy’s prior general rate cases, captioned above. On November 26, 2024, the Office of the Public Counsel (OPC) timely filed its concerns with the new charges.

On January 7, 2025, the Commission conducted a procedural conference with the parties to discuss the appropriate case in which to address OPC’s concerns. During discussion, two potential cases emerged: Evergy’s next general rate case or Evergy’s next FAC prudence review. This notice acknowledges that OPC’s issue will be allowed to be carried forward, even though the specific case number is unknown at this time.

When a case number is assigned to either Evergy’s next general rate case, or Evergy’s next FAC prudence review, OPC may file its concerns in that case number.
