ORDER CANCELING REGISTRATION

Issue Date: January 8, 2025

Effective Date: January 18, 2025

On September 19, 2024, Asset Black, LLC filed a letter seeking to cancel its registration to provide Interconnected Voice over Internet Protocol service (“IVoIP”) in the State of Missouri. The Commission granted Asset Black, LLC its IVoIP registration in the State of Missouri in File No. DA-2016-0158.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Asset Black, LLC’s request, the Commission finds that the IVoIP registration granted to Asset Black, LLC shall be canceled.

IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Asset Black, LLC in File Number DA-2016-0158, is canceled.
2. This order shall become effective on January 18, 2025.
3. This case may be closed on January 19, 2025.
