On January 8, 2025, Missouri American Water Company (MAWC) filed a proposed tariff revision, Tracking Nos. JW-2025-0101 and JS-2025-0102, which bear an effective date of February 7, 2025. The Commission will direct its Staff (Staff) to file a recommendation about the tariff sheets, and will set a time for filing any other comments.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation about MAWC's tariff revisions no later than January 20, 2025.
2. Any other comments about MAWC's tariff revisions shall be filed no later than January 20, 2025.
