ORDER DIRECTING RESPONSES

On August 27, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) jointly filed an application requesting that the Commission approve the sale and purchase between them of nineteen small wastewater systems. The Staff of the Commission (Staff) filed its Recommendation that the Commission grant its approval, subject to twelve conditions.

On January 9, 2025, the Office of the Public Counsel (OPC) filed its *Response to Staff Recommendation* (Response). The Response proposed four additional conditions, or, in the alternative, requested an evidentiary hearing.

The Commission will direct Confluence Rivers and MAWC to respond, and will set a time for responses by other parties.

THE COMMISSION ORDERS THAT:

1. Confluence Rivers and MAWC shall file its response to OPC's Response, or a request for an extension of time, no later than January 21, 2025.

2. Responses from other parties to OPC's Response shall be filed no later than January 21, 2025.

3. This order is effective when issued.
