The parties have reached an agreement resolving the issues in the case and were directed to file a status report or a settlement agreement no later than September 4, 2024. The deadline was later extended to September 30, 2024, October 31, 2024, December 6, 2024, and January 10, 2025.

On January 10, 2025, Spire Missouri Inc. d/b/a Spire filed a status report which included a request for an extension of time to file a further status report or settlement agreement by February 10, 2025. Spire indicated the agreement of the Staff of the Commission and the City of Kansas City to the request.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The parties shall file a status report, a settlement agreement, or a request for an extension of time no later than February 10, 2025.
2. This order shall be effective when issued.
