ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On January 10, 2025, Union Electric Company d/b/a Ameren Missouri (herein after Ameren) submitted an application requesting financing authorization in the amount of \$500 million through March 9, 2025, subject to all of the terms and conditions approved by the Commission.

Ameren also requests waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017. Ameren further requests expedited treatment such that the Commission issues a final order in this matter no later than February 27, 2025.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding Ameren's application.

THE COMMISSION ORDERS THAT:

1. No later than January 27, 2025, Staff shall file a recommendation regarding Ameren's application requesting financing authorization in the amount of \$500 million, or a request for an extension of time.
2. This order shall be effective when issued.

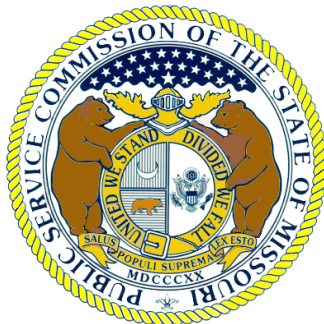
