On February 2, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a general rate case with the Commission. The Commission gave public notice of the application and set a February 20, 2024, intervention deadline.

On December 14, 2024, after the Commission issued its Report and Order to conclude the case, Clarksdale Public Utilities Commission (CPUC) filed an application to intervene. In its application, CPUC stated that it did not receive notice of this case.

Commission Rule 20 CSR 4240-2.075(10) allows the Commission to grant a motion to intervene after the intervention date "upon a showing of good cause." The Commission notes that the application to intervene claims that certain paragraphs of its notice therein which merely recount certain aspects of its organization or facts about the case amount to good cause, notes that CPUC admits it became aware of the case nearly 40 days before it sought to intervene, and consequently, finds that CPUC being unaware despite the Commission's notice, and that CPUC's intervention application being almost

ten months late, does not rise to the level of good cause. Consequently, the Commission will deny CPUC's untimely application to intervene.

## THE COMMISSION ORDERS THAT:

- 1. CPUC's application to intervene is denied.
- 2. This order shall be effective when issued.
