### ORDER REGARDING MOTION FOR RECONSIDERATION

Issue Date: January 15, 2025 Effective Date: January 15, 2025

On September 30, 2024, Union Electric Company d/b/a Ameren Missouri filed the above-reference rate case. That filing included a Motion to Allow Parties to Make Discrete Adjustments. The Commission's Staff and the Office of the Public Counsel opposed the Motion. On October 30, 2024, the Commission denied the Motion in its Order Setting Procedural Schedule.

On November 12, 2024, Ameren Missouri filed a Motion for Reconsideration. In the Motion, Ameren Missouri reiterates its request for a discrete adjustment for the second phase of its Northeast Territory project, Highway 161 to Silex (Northeast Territory Phase 2, a project expected to go into service in July, 2025). Ameren Missouri states that the discrete adjustment will provide for a complete factual record for the Commission to determine that the Northeast Territory Phase 2 project was completed and placed into service prior to rates going into effect, and thus known and measurable.

Upon review of the Motion for Reconsideration, the Commission finds that all parties are permitted to present discrete adjustments beyond the true-up period to propose a more complete picture of Ameren Missouri's operations at the operation of law date.

### THE COMMISSION ORDERS THAT:

- 1. The Motion for Reconsideration is granted.
- 2. This order is effective when issued.
