On December 12, 2024, the Staff of the Commission (Staff) filed its recommendation and memorandum regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO's) Actual Cost Adjustment filing. Staff expressed some concerns, comments, and recommendations.

On January 15, 2025, SNGMO filed its *Response to Staff's Recommendation and Memorandum* (Response). The Response addressed Staff's concerns, comments, and recommendations, and also noted a slight discrepancy in the ending balance for the Warsaw service area. The Response stated that SNGMO has provided documentation to Staff supporting a corrected ending ACA balance.
