**ORDER GRANTING MOTION FOR CLARIFICATION**

On December 20, 2024, Union Electric Company d/b/a Ameren Missouri filed a *Motion for Clarification and Reconsideration to Include Additional Measures Included in the MEEIA 4 Plan to the TRM* (Motion). Ameren Missouri states that the Commission's December 11, 2024 Order Regarding Motions for Expedited Treatment and Tariff appears to have inadvertently excluded TRM measures that were included in the Stipulation and Agreement and excluded from the list in Staff's Appendix A.

Ameren Missouri included a Revised Appendix A with its Motion. Revised Appendix A lists additional measures that were contemplated by the signatories' Non-Unanimous Stipulation and Agreement. The Motion further states that Ameren Missouri has consulted with the Commission's Staff, and that Staff does not object to the measures listed in Revised Appendix A.

The Commission allowed parties until December 27, 2024, to object. No objections were received.

The Commission finds that it should clarify its December 11, 2024 Order to include the additional measures listed in Revised Appendix A of Ameren Missouri's Motion in Ameren Missouri's MEEIA 4 Plan.

**THE COMMISSION ORDERS THAT:**

1. Ameren Missouri's Motion for Clarification is granted.
2. The Commission clarifies that its *Order Regarding Motions for Expedited Treatment and Tariff* includes the Revised Appendix A that includes measures in the Program Templates that were excluded from the original Appendix A.
3. This order shall be effective when issued.
