On November 27, 2024, the Staff of the Commission (Staff) filed *Staff's Gas Incident Report*. Spire Missouri Inc. d/b/a Spire filed its response on January 10, 2025. Staff had a total of twelve recommendations and Spire accepted all but the last.

1. No later than January 31, 2025, Staff shall file a response to Spire's concerns with recommendation twelve.

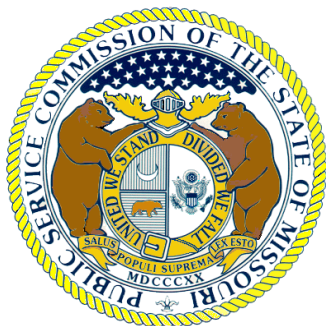
