STAFF RECOMMENDATION TO APPROVE REVISED TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Revised Tariff Sheet* and states as follows:

1. On September 3, 2024, Missouri-American Water Company (MAWC) filed a petition to change water and sewer infrastructure rate adjustments (WSIRAs) under §§393.1500-1509, RSMo, and filed tariff sheets to implement the WSIRAs. The tariff sheets, Tracking Nos. JW-2025-0026 and JS-2025-0027, were suspended by the Commission until March 2, 2024.

2. On January 8, 2025, the Commission entered an *Order Approving Water and Sewer Infrastructure Rate Adjustments*, rejecting the tariff sheets filed by MAWC on September 3, 2024 (Tracking Nos. JW- 2025-0026 and JS-2025-0027), authorizing MAWC to establish WSIRAs for water and sewer service, and authorizing MAWC to file tariff sheets to recover WSIRA revenues and rates as set out in the exemplar tariff sheets attached to its December 9, 2024 filing.

3. On January 8, 2025, MAWC filed a proposed tariff revision, bearing an effective date of February 7, 2025, and assigned Tracking Nos. JW-2025-0101 and JS-2025-0102, in order to comply with the terms of the Commission’s January 8, 2025 *Order*.

4. Staff has reviewed the proposed tariff revision and recommends the Commission approve or allow the following to go into effect for service:

WATER

P.S.C. MO. No. 13

9th Revised Sheet No. RT 11.1, Cancelling 8th Revised Sheet No. RT 11.1

9th Revised Sheet No. RT 11.2, Cancelling 8th Revised Sheet No. RT 11.2

SEWER

P.S.C MO. No. 26

8th Revised Sheet No. RT 11.1, Cancelling 7th Revised Sheet No. RT 11.1

8th Revised Sheet No. RT 11.2, Cancelling 7th Revised Sheet No. RT 11.2

WHEREFORE, Staff recommends the Commission either issue an order approving the revised tariff sheets filed in this matter in Tariff Tracking Nos. JW-2025-0101 and JS-2025-0102, or allow the same revised tariff sheets to go into effect by operation of law.
