ORDER DIRECTING RESPONSE

On December 11, 2024, Ameren Transmission Company of Illinois (ATXI) filed an application with the Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) for 345 kV transmission lines across a portion of North Central Missouri and for authority to transfer an ownership interest in a portion of the transmission lines to the Missouri Joint Municipal Electric Utility Commission.

On January 16, 2025, the Office of the Public Counsel (OPC) filed a *Motion for a Commission Order to Make Information Public*, alleging that ATXI's application, as well as prefiled testimony ATXI filed with its application, has not followed Commission rules regarding information designated as confidential.

The Commission will direct ATXI to respond to OPC's motion and will also set a deadline for other parties to respond.

THE COMMISSION ORDERS THAT:

1. ATXI shall file a response to OPC's *Motion for a Commission Order to Make Information Public* no later than January 27, 2025.

2. Any other responses to OPC's *Motion for a Commission Order to Make Information Public* shall be filed no later than January 27, 2025, and may be filed by persons or entities not yet granted intervention.

3. This order shall be effective when issued.
