### ORDER GRANTING EXTENSION

Issue Date: January 21, 2025 Effective Date: January 21, 2025

On August 27, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) jointly filed an application requesting that the Commission approve the sale and purchase between them of nineteen small wastewater systems. The Staff of the Commission (Staff) filed its Recommendation that the Commission grant its approval, subject to twelve conditions.

On January 9, 2025, the Office of the Public Counsel (OPC) filed its *Response to Staff Recommendation* (Response). The Response proposed four additional conditions, or, in the alternative, requested an evidentiary hearing.

The Commission directed Confluence Rivers and MAWC to respond, and set a time for responses by other parties. On January 17, 2025, Staff, Confluence Rivers, and MAWC filed their *Joint Motion for Extension of Time to File a Reply to the Office of Public Counsel Response* (Joint Motion). The Joint Motion requested an extension of time to January 28, 2025, to file their response as Confluence, MAWC, and Staff will potentially

file a joint reply to OPC's Response.

The Commission finds the request for an extension reasonable and will grant it.

#### THE COMMISSION ORDERS THAT:

- 1. The Joint Motion is granted.
- 2. Confluence Rivers and MAWC shall file its response to OPC's Response, or a request for an extension of time, no later than January 28, 2025.
- 3. Responses from other parties to OPC's Response shall be filed no later than January 28, 2025.
  - 4. This order is effective when issued.
