ORDER APPROVING DEMAND SIDE INVESTMENT MECHANISM RIDER RATE ADJUSTMENT TARIFF

Issue Date: January 21, 2025 Effective Date: February 1, 2025

On December 2, 2024, Evergy Metro, Inc. d/b/a Evergy Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) filed tariffs, with supporting testimony, to adjust charges related to their approved Demand Side Investment Mechanism (DSIM) Rider sunder the Missouri Energy Efficiency Investment Act (MEEIA). The tariffs were assigned Tracking No. JE-2025-0085 and JE-2025-0086, and they have an effective date of February 1, 2025.

The Commission issued notice of the filing, set an intervention deadline, and directed the Staff of the Commission (Staff) to submit Recommendations. On January 17, 2025, Staff recommended the Commission approve the tariffs. No responses or objections were received to either the tariffs or Staff's Recommendations.

Commission Rules 20 CSR 4240-20.093(4) and 20 CSR 4240-3.162(8) require Evergy to make adjustments of its DSIM rates to reflect the amount of revenue that has been over- or under-collected. For Evergy Metro, the proposed tariff sheet increases the current residential DSIM Rider rate from \$0.00329 per kWh to \$0.00493 per kWh for residential customers. For a residential customer using 1,000 kWhs, this change will increase the customer's bill by \$1.64 per month.

Non-residential customer impacts would be as follows:

Small General Service from \$0.00152 per kWh to \$0.00407;

Medium General Service from \$0.00372 per kWh to \$0.00554

Large General Service from \$0.00173 per kWh to \$0.00233; and

Large Power Service from \$0.00187 per kWh to \$0.00156.

For a non-residential customer using 1,000 kWh monthly, this would result in the following monthly billing changes:

Small General Service, a \$2.55 increase;

Medium General Service, \$1.82 increase;

Large General Service, a \$0.60 increase; and

Large Power Service, a \$0.31 decrease.

For Evergy Missouri West, the proposed tariff sheet increases the current residential DSIM Rider rate from \$0.00234 per kWh to \$0.00258 per kWh for residential customers. For a residential customer using 1,000 kWhs, this change will increase the customer's bill by \$0.24 per month.

Non-residential customer impacts would be as follows:

Small General Service from \$0.00179 per kWh to \$0.00260;

Large General Service from \$0.00173 per kWh to \$0.00356; and

Large Power Service from \$0.00069 per kWh to \$0.00468.

For a non-residential customer using 1,000 kWh monthly, this would result in the following monthly billing changes:

Small General Service, a \$0.81 increase;

Large General Service, a \$1.83 increase; and

Large Power Service, a \$3.99 increase.

Commission Rule 20 CSR 4240-20.093(4), regarding adjustment of DSIM rates between general rate proceedings, states that if the proposed adjustments are in accordance with the rule, with Section 393.1075, RSMo, and with the previously-approved DSIM, the Commission shall issue an order approving the tariff within sixty days after the tariff is filed. The Commission has reviewed the tariff sheets, Staff's Recommendation and attached Memorandum, and finds that the proposed tariff sheets implementing the DSIM rate adjustments are in compliance with Evergy's existing DSIM tariff and with all applicable statutes and regulations.

So that the tariff sheet will be effective at the time requested, the Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Evergy Metro's tariff sheet, assigned Tracking No. JE-2025-0085, is approved to be effective February 1, 2025. The tariff sheet approved is:

2. Evergy Missouri West's tariff sheet, assigned Tracking No. JE-2025-0086, is approved to be effective February 1, 2025. The tariff sheet approved is:
