On December 13, 2024, the Staff of the Commission (Staff) filed its recommendation regarding Spire Missouri Inc. d/b/a Spire's Actual Cost Adjustment filing. Spire responded on January 13, 2025. In Spire's response, Spire proposed a settlement conference be held between the parties within thirty days and a joint status report be filed within sixty days of the filing of its response.

The Commission will direct the parties accordingly.

THE COMMISSION ORDERS THAT:

1. No later than February 12, 2025, Spire and Staff shall attend a technical/settlement conference.
2. No later than March 10, 2025, Spire and Staff shall file a joint status report, stipulation, or a joint procedural schedule.
3. This order shall be effective when issued.
