ORDER DIRECTING STAFF TO FILE RECOMMENDATION

Effective Date: January 23, 2025

On January 22, 2025, Evergy Metro, Inc. and Evergy Missouri West, Inc. (together “Evergy”) submitted applications requesting a waiver of 20 CSR 4240-3.155(3). That provision requires electric utilities to update and revise certain tariffs and data by January 15 of every odd numbered year.

Evergy requested a waiver of the rule to permit it to file after January 15, and also requested approval of revised tariff sheets relating to Biennial Parallel Generation. The submitted tariff sheets have an effective date of February 21, 2025.

The Commission will direct the Staff of the Commission (Staff) to file a Recommendation regarding Evergy’s waiver request as well as a Recommendation regarding the submitted tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than January 31, 2025, Staff shall file a Recommendation regarding the waiver request as well as a Recommendation regarding the submitted tariff sheets or a status report regarding when it expects to file its Recommendation.
2. Other comments regarding the waiver request or the submitted tariff sheets shall be submitted no later than January 31, 2025.
3. This order shall be effective when issued.
