### ORDER SETTING TIME FOR RESPONSES

Issue Date: January 24, 2025 Effective Date: January 24, 2025

On February 15, 2022, the Commission issued an order opening an investigation into Union Electric Company d/b/a Ameren Missouri's plans to retire its Rush Island Energy Center (Rush Island). Pursuant to federal court order Rush Island is no longer operating. That order also directed Ameren Missouri to file a monthly report on the status of proceedings at the federal court and its planning for the retirement of Rush Island. Those reports were to continue until the Commission directed otherwise.

On January 21, 2025, Ameren Missouri filed a motion to cease monthly reporting now that Rush Island has retired and the federal court has issued its remediation order. Prior to ceasing Ameren Missouri's monthly Rush Island reporting requirement, the Commission will set a deadline for any responses that monthly reporting should continue.

#### THE COMMISSION ORDERS THAT:

- 1. Any responses to Ameren Missouri's motion to cease monthly Rush Island reporting are due no later than February 4, 2025.
  - 2. This order shall be effective when issued.
