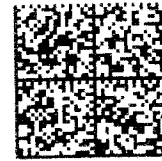

Commission rule 4 CSR 240-20.094(8)(B), a part of the Commission's rules that implement the Missouri Energy Efficiency Investment Act (MEEIA), calls for the formation of a state-wide advisory collaborative to deal with MEEIA issues. On June 13, 2013, the Commission's Staff filed a motion asking the Commission to open a working case to assist that collaborative in the collection and evaluation of information and to serve as a repository for documents and comments. The first meeting of the collaborative will be held on July 31, 2013 and Staff asks the Commission to provide notice of that meeting to potentially interested stakeholders. Information about that meeting is attached to this order.

comment without counsel and without *ex parte* constraints (arising from this matter). Intervention requests are not necessary to submit comments or view documents.


