**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH
COMMISSION ORDER**

Issue Date: January 24, 2025

Effective Date: February 7, 2025

On January 8, 2025, the Commission issued its order approving water and sewer infrastructure rate adjustments. That order rejected the previously filed tariff revisions and directed Missouri-American Water Company (MAWC) to file tariff sheets in compliance with the Commission’s order.

MAWC filed compliance tariff sheets on January 8, 2025. The Staff of the Commission (Staff) recommended that the Commission approve MAWC’s compliance tariff sheets. No other responses to MAWC’s tariff sheets were received.

After reviewing the compliance tariff sheets and Staff’s recommendation, the Commission finds that the tariff sheets comply with the Commission’s *Order Approving Water and Sewer Infrastructure Rate Adjustments*. So that Ameren Missouri can implement the compliance tariff sheets on their effective date, the Commission finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:
