ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On January 17, 2025, Summit Natural Gas of Missouri, Inc. (SNGMO) submitted an application requesting authorization to issue private placement notes.

SNGMO also seeks expedited treatment of its financing application, requesting that the Commission order a decision on the application be effective no later than 90 days after the filing of the application. In addition, SNGMO requests a waiver of the 60-day notice requirement under Commission rule 20 CSR 4240-4.017.

The Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file an expedited recommendation, or alternative pleading, regarding SNGMO's application.

THE COMMISSION ORDERS THAT:

1. No later than March 24, 2025, Staff shall file a recommendation or alternative pleading regarding SNGMO's application requesting authority to issue private placement notes of long-term indebtedness.
2. This order shall be effective when issued.
