## SECOND ORDER GRANTING MOTION FOR EXTENSION OF TIME

On December 2, 2015, the Commission issued an *Order Opening a Working Case Regarding Electric Vehicle Charging Facilities*, which established a deadline of June 1, 2016 for Staff to file a report of its findings and August 1, 2016 for other persons to file comments to the Staff report. On May 6, 2016, the Commission granted Staff a thirty-day extension of those filing deadlines. On June 23, 2016, Staff requested a further thirty-day extension of time in order to evaluate the extensive information provided at the workshop before filing its report. The Commission finds the request reasonable and will grant it

### THE COMMISSION ORDERS THAT:

1. Staff's *Motion for Extension of Time to File Report* filed on June 23, 2016, is granted.
2. The deadline for Staff to file a report of its findings and recommendations is extended until no later than August 1, 2016.
3. The deadline for other persons or entities to respond or comment on the Staff report is extended until no later than October 1, 2016.

4. This order shall be effective when issued.
