## MOTION FOR ADOPTION OF ANCILLARY PROCEDURAL SCHEDULE

COME NOW Folsom Ridge LLC and Big Island Homeowners Water and Sewer Association, Inc. (sometimes collectively referred to as "Respondents" or "Applicants") and move the Commission to adopt an ancillary procedural schedule in these matters joined for hearing for purposes of accepting additional testimony on issues first raised at hearing. In support thereof, Respondents submit the following to the Commission:

- 1. The Commission subpoenaed Mr. John MacEachen, an Environmental Specialist with the Missouri Department of Natural Resources, presently attached to its enforcement division, who appeared and testified the last day of hearing of these matters on Friday, March 2, 2007. During his testimony he fielded questions from the Commission and the parties pertaining to photographs offered by Mr. Ben Pugh, particularly regarding the specifications and characteristics of flexible piping used for service lines on Big Island, and the manner in which service lines for water and sewer lines shared the same "metering" or access pit.
- 2. At the close of hearing on March 2, 2007, Respondents sought leave to supply additional testimony on the nature of the service line installations and leave was granted. On Monday, March 5, 2007, the parties were canvassed by electronic mail about a schedule within which to provide additional written testimony limited to this topic. Based upon the parties' responses, Respondents request the Commission to adopt the following schedule:

file Rebuttal Testimony March 19, 2007

All parties file Surrebuttal Testimony March 26, 2007

3. The schedule has been designed to allow seven day intervals between filing deadlines. At this time, Respondents can represent that counsel for staff, the Office of Public Counsel and Ms. Cindy Fortney have no objection to the relief set out herein, and anticipate that no other party will have an objection.

WHEREFORE, Respondents respectfully request the Commission to approve the foregoing procedural schedule for purposes of filing written testimony limited to subject matters described herein.
