## ORDER CANCELING CERTIFICATE

Issue Date: January 17, 2020

Effective Date: February 16, 2020

On December 18, 2019, Fidelity Systems Plus, Inc. filed a letter purporting to cancel its certificate of service authority to provide payphone services in Missouri. The Staff of the Missouri Public Service Commission responded on January 2, 2020, by filing a motion asking the Commission to cancel the certificate of service authority provided private payphone service to Fidelity Systems Plus in File No. TA-98-123 on November 25, 1997.

On January 2, 2020, the Commission issued an order allowing parties until January 13, to respond or request a hearing. No response was filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo 2016 which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Fidelity Systems Plus’s request and Staff’s motion, the Commission finds that the private payphone certificate granted to Fidelity Systems Plus, shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The private payphone certificate granted to Fidelity Systems Plus, Inc., in File Number TA-98-123, is canceled.
2. This order shall become effective on February 16, 2020.
3. This case may be closed on February 17, 2020.
