On October 18, 2024, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. Ameren Missouri wishes to own, operate, maintain, and otherwise control and manage a new substation, and to reconfigure an existing transmission substation, in Cooper County, Missouri. The Commission granted intervention to certain parties, and ordered the parties to file a proposed procedural schedule or a status report no later than January 27, 2025.

On January 27, 2025, the parties filed a Status Report. The parties state that they can file either a proposed procedural schedule or a status report by February 3, 2025.

The Commission finds the parties' request reasonable, and will grant it.
