On January 13, 2020, Gateway Fiber LLC (Gateway Fiber) filed a Notice of Change Application. Pursuant to 20 CSR 4240-2.080(1), pleadings filed with the Commission must be signed by at least one attorney of record authorized to practice law in Missouri.

The Commission will leave the file open until February 15, 2020, to allow Gateway Fiber to correct the deficiency. If no response is filed by that time, the Commission will reject the request and close the file.
