ORDER CLARIFYING THE TIME IN WHICH TO FILE THE PROPOSED PAYS PILOT PROGRAM

Issue Date: January 21, 2020 Effective Date: February 20, 2020

The Commission issued a Report and Order on December 11, 2019, regarding the Missouri Energy Efficiency Investment Act (MEEIA) Cycle 3 program submitted by Evergy Missouri Metro and Evergy Missouri West (Evergy). That Report and Order became effective on January 1, 2020. Evergy filed a timely application for clarification and/or rehearing, and the Office of the Public Counsel filed a timely application for rehearing. Both applications remain pending before the Commission and are not addressed by this order.

The Commission notes that the Report and Order - specifically ordered paragraph 2 - requires Evergy and the parties to file a proposed Pay As You Save (PAYS) pilot program within 60 days of the effective date of the report and order. The report and order was effective on January 1, 2020, so, by the terms of the report and order, the proposed PAYS pilot program would need to be filed by March 1, 2020. The report and order also provided that Evergy could offer the one-year PAYS pilot program at a time of its choosing, sometime during the three-year MEEIA Cycle 3 period. The Commission's intent was that the proposed PAYS pilot program be filed at least 60 days before the

program would be put into effect, not 60 days after the effective date of the report and order.

On its own motion, the Commission will relieve the parties of their obligation to file a proposed PAYS pilot program by March 1, 2020.

THE COMMISSION ORDERS THAT:

- 1. Evergy and the parties are relieved of their obligation to file a one-year PAY As You Save (PAYS) pilot program by March 1, 2020. Instead, Evergy, after consulting with the parties, shall file a one-year Pay As You Save (PAYS) pilot program at least 60 days before such pilot program is to go into effect.
 - 2. This order shall be effective on February 20, 2020.
