ORDER APPROVING COMPLIANCE TARIFF WITH EXPEDITED EFFECTIVE DATE

Issue Date: January 21, 2020 Effective Date: February 1, 2020

On January 15, 2020, the Commission approved the Initial Stipulation and Agreement between Union Electric Company d/b/a Ameren Missouri and the Staff of the Commission and also suspended the MEEIA adjustment tariff sheets, Tracking No. YE-2020-0090, until February 1, 2020. The suspension order also directed Ameren Missouri to file tariff sheets consistent with the exemplar tariff sheets attached to the stipulation and agreement.

Ameren Missouri substituted its Tariff Sheet 91.23 on January 17, 2020, in compliance with the Commission's order. Tariff Sheet 91.23 bears a March 15, 2020 effective date. The remaining tariff sheets in Tariff Tracking No. YE-2020-0090 have been suspended by Commission order until February 1, 2020. Ameren Missouri also filed a motion requesting that Tariff Sheet 91.23 and the other tariff sheets in Tariff Tracking No. YE-2020-0090 be approved to become effective on February 1, 2020. The stipulation

and agreement and the Commission's order approving that stipulation and agreement contemplated a February 1, 2020 effective date for the compliance tariff sheet and Tariff Tracking No. YE-2020-0090. Additionally, the new rates and the other provisions of the tariff sheets were based on becoming effective on that date.

The Staff of the Commission has previously recommended that the tariff sheets as attached to the stipulation and agreement be approved. Further, the Office of the Public Counsel did not object to the stipulation and agreement proposing these tariff sheets be approved. The Commission has reviewed the compliance filing (Tariff Sheet 91.23), the recommendation of Staff, and the provisions of the approved stipulation and agreement and finds that the compliance filing is consistent with the exemplar tariff sheets attached to the stipulation and agreement. Therefore, the Commission determines that that Tariff Tracking NO. YE-2020-0090, as substituted on December 3, 2019, December 10, 2019, and January 17, 2020, should be approved. The Commission also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo 2016, to expedite the effective date of the tariff sheets. In addition, this order will be effective in less than thirty days so that the order will be effective concurrently with the tariff sheets. Therefore, the Commission will approve these tariff sheets to become effective on February 1, 2020.

THE COMMISSION ORDERS THAT:

- 1. The motion for an expedited tariff effective date filed by Union Electric Company d/b/a Ameren Missouri on January 17, 2020, is granted.
- 2. The tariff sheets filed by Union Electric Company d/b/a Ameren Missouri on November 22, 2019 (Tariff Tracking No. YE-2020-0090), as substituted on

December 3, 2019, December 10, 2019, and January 17, 2020, are approved to become effective on February 1, 2020.

3. This order is effective on February 1, 2020.
