# **ORDER GRANTING LEAVE TO FILE** SUPPLEMENTAL DIRECT TESTIMONY

On January 9, 2020, the Staff of the Commission (Staff) filed a motion requesting leave to supplement the Direct Testimony of Sarah L.K. Lange. Staff indicated that it needed to revise the recommended rates contained in Staff's Class Cost of Service Report because of an error in the report concerning the treatment of the temporary tax rider.<sup>1</sup> The proposed revision changes Staff's position by decreasing the revenue responsibilities of the classes and decreasing Staff's recommended rates. Staff attached the Supplemental Direct Testimony of Sarah L.K. Lange to its motion. Staff also stated it would provide the workpapers supporting the changes to the parties.

Commission rule 20 CSR 4240-2.080(13) states that parties shall be allowed ten days from the date of filing in which to respond to a pleading. Commission rule 20 CSR 4240-2.050(1) extends the filing date to the end of the next date that is not a Saturday, Sunday, or legal holiday. Ten days from the date of filing was January 19, 2020, a Sunday, and the following day, January 20, 2020, was a legal holiday. Thus, the deadline to file a response to Staff's motion was Tuesday, January 21, 2020. No responses were filed.

The Commission has considered Staff's unopposed motion and will grant it.
