ORDER APPROVING TARIFF SHEET NO. 91.22

Issue Date: January 24, 2020

Effective Date: January 27, 2020

On January 21, 2020, the Commission issued an Order Approving Compliance Tariff with Expedited Effective Date that approved tariff sheets in Tariff Tracking Number YE-2020-0090. That order has an effective date of February 1, 2020. The tariff sheets had been filed in compliance with the Commission's earlier order approving an agreement between Union Electric Company, d/b/a Ameren Missouri and the Staff of the Commission. The tariff sheets had been suspended by the Commission until February 1, 2020, to match the date the approval of the agreement would be effective, based on a representation by Ameren Missouri that the tariff sheets did not need to go into effect until February 1, 2020.

On January 24, 2020, Ameren Missouri filed a request for clarification of the Commission's January 21, 2020 order. Ameren Missouri states that it has now determined that Tariff Sheet No. 91.22 needs to become effective by January 27, 2020, to implement the shift from billing month to calendar month noted in that tariff sheet. No changes have been made to Tariff Sheet No. 91.22 since it was originally filed on November 22, 2019, and no party has opposed any aspect of that tariff sheet.

Ameren Missouri also states that it has discussed its request to make Tariff Sheet No. 91.22 effective on January 27, 2020, with Staff and the Office of the Public Counsel,

the only other parties to this case, and neither party objects. Therefore, the Commission will approve Tariff Sheet No. 91.22 to become effective on January 27, 2020.

Because of the expedited nature of the request and the fact that all parties agree, the Commission determines this order should become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. Tariff Sheet No. 91.22 filed on November 22, 2019, as part of Tariff Tracking No. YE-2020-0090 is approved to become effective on January 27, 2020.
2. All other tariff sheets that are part of Tariff Tracking No. YE-2020-0090 will become effective on February 1, 2020, as previously ordered.
3. This order is effective January 27, 2020.
