On November 26, 2024, the Commission issued its *Order Granting Motion Regarding Information Designated as Confidential* (Order). On January 27, 2025, the Office of the Public Counsel filed *Public Counsel's Motion to Enforce Order* (Motion).

The Motion argues that the Order has not been complied with, and requests that the Commission issue an order directing The Empire District Electric Company to show cause why the information for which it claims confidentiality should be withheld from public access in this proceeding.

The Commission will direct The Empire District Electric Company to respond and set a time for other parties to respond.

THE COMMISSION ORDERS THAT:

1. The Empire District Electric Company shall respond to OPC's Motion no later than February 6, 2025.
2. Any other responses to OPC's Motion shall be filed no later than February 6, 2025.
3. This order is effective when issued.
