#### MOTION TO LATE FILE COMMENTS INSTANTER

COMES NOW Wind on the Wires, by counsel, and hereby petitions the Public Service Commission of the State of Missouri ("PSC" or "Commission") for leave to file comments out of time pursuant to 4 CSR 240-2.080. In support of this motion, Wind on the Wires states and alleges the following:

- On May 15, 2018 a copy of the proposed rules for filing requirements for electric utility applications for certificate of convenience and necessity was published in the Missouri Register (vol. 43, num. 10). With the rules was a public notice to submit comments on or before June 14, 2018.
- 2. Wind on the Wires prepared comments and an accompanying schedule to file on June 14, however, due to issues with Wind on the Wires computer system Wind on the Wires was unable to convert the documents to PDF for filing. The issue did not become apparent until early evening on the 14<sup>th</sup>, when computer support staff was unavailable to correct the problem.
