Hey Brett! Thanks for pointing that out. I'm going to add something to this if I may.

While Brett might have been lenient or extremely lenient about giving you opportunity to come clean about the document. Lack of response or no response gave me all I need. In fact, Mr. John Clark I noticed likes to use his position and title within the Missouri Public Service Commission . Abuse of power.

I reached out to the FBI this morning and filed a complaint and submitted a copy of Exhibit D. I'm not involved in the company, however when a counterfeit document comes through to my server and it has a bogus email address and bogus coding words, I have to report it by law.
