ORDER GRANTING STAFF’S MOTION FOR EXTENSION OF TIME

On January 10, 2025, Union Electric Company d/b/a Ameren Missouri (Ameren) filed a *Motion for Expedited Treatment and Application For Financing Authority* Requesting that the Commission expedite their request to authorize financing. On January 13, 2025, the Commission ordered Staff to file a recommendation or request for an extension of time no later than January 27, 2025. On January 27, 2025, Staff filed a *Motion for an Extension of Time* to file a Staff recommendation. Staff requests an additional eighteen days to file their recommendation and requests a due date of February 14, 2025.

THE COMMISSION ORDERS THAT:

1. The Commission shall grant the Staff’s *Motion for an Extension of Time* to file their recommendation.
2. No later than February 14, 2025, the Staff of the Commission shall file a recommendation regarding Ameren’s application.
3. This order shall be effective when issued.
