# ORDER SETTING PROCEDURAL SCHEDULE

On December 19, 2024, the Commission ordered the Staff of the Commission (Staff) to file a joint proposed procedural schedule on behalf of all of the parties. Staff filed a *Motion for Extension to File Proposed Procedural Schedule* on January 10, 2025, which was granted the same day. Staff filed its *Proposed Procedural Schedule* on January 24, 2025.

The Commission has reviewed the proposed procedural schedule and will adopt it, setting an evidentiary hearing date during the dates proposed. In addition, the Commission will add procedural requirements to the schedule.

- 2. The hearing shall begin at 9:00 a.m. and will be held in Room 310 at the Commission's office at the Governor's Office Building, 200 Madison Street, Jefferson City Missouri, with remote connectivity via WebEx. The link, access telephone numbers, and access code to participate in the hearing will be emailed to all parties. Those who need additional accommodations to participate in this hearing may call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.
  - 3. The parties shall comply with the following procedural requirements:
    - a. Although not all parties may agree upon how each issue should be described or on whether a listed issue is in fact a proper issue in this case, the parties shall agree upon and file a list of the issues to be heard, the order in which witnesses will be called, and the order of cross-examination for each witness. The Commission will view any issue not contained in this list of issues as not requiring resolution by the Commission.
    - c. All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 20 CSR 4240-2.080.
    - d. Exhibit numbers are assigned in the following manner:

- e. Each party shall prepare a list of its pre-filed, pre-marked exhibits and file a copy of that list in the Commission's Electronic Filing and Information System (EFIS). Exhibits that may be offered during cross-examination, but which have not been pre-filed, need not be included on the list. However, when those documents are offered during the hearing, they will be assigned a number from that party's number group.
- 4. The parties shall provide a copy of all exhibits electronically to the other parties and the Regulatory Law Judge no later than April 15, 2025.
