On January 14, 2025, ExteNet LVS, LLC, pursuant to Sections 392.611.4 and 392.550, RSMo, filed an application for authorization to provide Interexchange (IXC) and Non-Switched Local Exchange Telecommunications Services in the following exchanges:

Statewide

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo.¹ The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing.

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

THE COMMISSION ORDERS THAT:

1. ExteNet LVS, LLC is registered and granted certification to provide IXC and Non-Switched Local Exchange Telecommunications Services in the exchanges set forth in the affidavit attached to the application and restated above.

¹ Subsection 392.611.4, RSMo, states that “[a]fter August 28, 2014, telecommunications companies seeking to provide telecommunications service may, in lieu of the process and requirements for certification set out in other sections, elect to obtain certification by following the same registration process set out in subsection 3 of section 392.550”
