## ORDER DIRECTING FISCAL COST REVIEW

The Commission's Order of Rulemaking for 20 CSR 4240-40.100 was published in the *Missouri Register* on November 15, 2024 (49 MoReg 1728-1731). The rule was subsequently published in the *Code of State Regulations* on November 30, 2024, and became effective on December 30, 2024.

Section 536.200, RSMo, requires a review of the fiscal costs to public entities of this rule at the end of the first full fiscal year after implementation of the rule. Thus, the Commission will order its Staff to conduct such fiscal review and file the results.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file the results of its public entity fiscal cost review of this rule no later than August 14, 2026.
2. This order shall be effective on January 31, 2025.
