**ORDER NUNC PRO TUNC**

On January 21, 2025, the Commission issued an Order Approving Demand Side Investment Mechanism Rider Rate Adjustment Tariff. The order incorrectly approved Tracking Nos. JE-2025-0085 and JE-2025-0086, which the companies withdrew on December 20, 2024, and replaced with Tracking Nos. JE-2025-0104 and JE-2025-0105.

This order corrects the January 21, 2025 order *nunc pro tunc*. Tracking Nos. JE-2025-0085 and JE-2025-0086 are not approved because they were withdrawn. Tracking Nos. JE-2025-0104 and JE-2025-0105 replace the incorrect numbers in the order, were approved by that order, and will become effective on February 1, 2025.

**THE COMMISSION ORDERS THAT:**

1. The Order Approving Demand Side Investment Mechanism Rider Rate Adjustment Tariff is corrected *nunc pro tunc* as described above.
2. This order shall be effective when issued.
