**ORDER GRANTING MOTION FOR EXTENSION
AND AMENDING PROCEDURAL SCHEDULE**

On August 7, 2024, the Commission issued its *Order Setting Procedural Schedule*.

The order included a deadline of January 30, 2025, for filing the List of Issues, Order of Witnesses, Order of Opening Statements, and Order of Cross Examination (collectively, “List of Issues”) and a deadline of February 10, 2025, for filing Statements of Position.

On January 30, 2025, the Staff of the Commission, with the agreement of the other parties, filed a *Motion for Extension* in which it requested extensions for the deadlines for filing the List of Issues and the Statements of Position to February 14, 2025, and February 21, 2025, respectively.

The Commission will grant the motion but with a minor variation.

THE COMMISSION ORDERS THAT:

1. The *Order Setting Procedural Schedule*, issued by the Commission on August 7, 2024, is amended as follows:

List of Issues, Order of Witnesses, Order of Opening Statements, and Order of Cross Examination	February 14, 2025
Statements of Position	February 21, 2025 12:00 p.m.

2. All other deadlines and procedural matters set out in the *Order Setting Procedural Schedule* remain unchanged.

3. This order shall be effective when issued.
