**ORDER DIRECTING STAFF TO FILE A COMPLIANCE TARIFF
RECOMMENDATION AND SETTING A TIME FOR RESPONSES**

On January 23, 2025, the Commission issued its *Order Approving Stipulation and Agreement*. On January 30, 2025, Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed tariff sheets to comply with the Commission’s order. The proposed tariff sheets bear an effective date of March 1, 2025.

The Commission will direct its Staff to file a recommendation about the proposed tariff sheets. The Commission will also establish a deadline for any other responses to the proposed tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation about Liberty’s proposed tariff sheets no later than February 11, 2025.
2. Any other responses to Liberty’s proposed tariff sheets or Staff’s recommendation shall be filed no later than February 14, 2025.

3. This order is effective when issued.
