On February 3, 2025, the Staff of the Commission (Staff) filed a Motion to Invite Comments Regarding Costs of Compliance. The Commission has ordered Staff to review the fiscal cost of this rule and to report to the Commission no later than August 29, 2025.<sup>1</sup> Staff states that comments from interested stakeholders would assist Staff in its fiscal cost analysis. Staff asks the Commission allow interested stakeholders to comment no later than June 16, 2025.

The Commission finds Staff's request reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

1. Any interested stakeholder who wishes to comment on the fiscal cost of this rule shall do so no later than June 16, 2025.
2. This order shall be effective when issued.
