# ORDER DIRECTING NOTICE AND STAFF RECOMMENDATION AND SETTING INTERVENTION AND RESPONSE DEADLINES

Issue Date: February 4, 2025 Effective Date: February 4, 2025

On January 31, 2025 Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) submitted direct testimony and an application to implement an adjustment to its Fuel and Purchased Power Adjustment Clause (FAC). This FAC tariff filing includes information which includes Evergy Metro's 16<sup>th</sup> recovery period resulting in a true-up over collected amount to be returned to customers. Evergy Missouri Metro requests that the Commission approve the over collected amount and authorizes that the amount be included in the next accumulation period.

Commission Rule 20 CSR 4240-20.090 provides a 60-day timeline for resolution of these rate adjustment mechanism proceedings. The Commission will direct notice be given and set a deadline for intervention applications. The Commission will also direct Staff to file a recommendation and set a deadline for responses from the Office of the

Public Counsel and other parties to the proposed fuel adjustment rate and/or proposed true-up amount.

Commission Rule 20 CSR 4240-20.090(17) provides that parties to the rate case in which the Commission continued Evergy Metro's fuel adjustment clause are automatically parties to this tariff case, without the necessity of having to apply for intervention.

# THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center notify the parties to file the service list for these cases and shall provide those parties with a copy of this order.
- 2. The Commission's Data Center shall provide notice of this order to the county commissions for each county in Evergy Metro's Missouri service territory.
- 3. Applications for intervention shall be filed no later than February 14, 2025. Any such filing shall be submitted through the Commission's electronic filing and information system (EFIS) or delivered to: Secretary, Missouri Public Service Commission, P.O. Box 360, Jefferson City, MO 65102-0360.
- 4. Staff shall file a recommendation regarding its examination and analysis of Evergy Metro's application and proposed tariff sheet no later than March 3, 2025.
- 5. Any responses by the Office of the Public Counsel or other parties to the application, tariff sheet, and/or Staff recommendations shall be filed no later than March 10, 2025.
  - 6. This order shall be effective when issued.
