ORDER GRANTING REQUEST FOR WAIVER AND APPROVING TARIFF SHEETS

Issue Date: February 5, 2025 Effective Date: February 21, 2025

On January 22, 2025, Evergy Metro, Inc. and Evergy Missouri West, Inc. (together "Evergy") submitted applications requesting a waiver of 20 CSR 4240-3.155(3). That provision requires electric utilities to update and revise certain tariffs and data by January 15 of every odd numbered year.

Evergy requested a waiver of the rule to permit it to file after January 15, and also requested approval of revised tariff sheets relating to Biennial Parallel Generation. The submitted tariff sheets have an effective date of February 21, 2025. Evergy stated that its request for a waiver is necessary due to an administrative oversight. The Commission directed its Staff (Staff) to file a recommendation, and set a time for other parties to respond to Evergy's application and tariff sheets.

On January 31, 2025, Staff filed its recommendation. Staff stated it did not object to Evergy receiving a one-time waiver of 20 CSR 4240-3.155(3). Staff stated that it reviewed the tariff sheets and recommended they be approved. Staff noted that each tariff sheet identified that it was cancelling an original sheet, but should instead state it is cancelling the respective revised sheet. Evergy filed substitute tariff sheets on January 31, 2025, to correct the reference. The substitute tariff sheets are before the Commission. Besides Staff, no other party responded to Evergy's application or tariff sheets.

The Commission has reviewed the applications, the tariff sheets as substituted, Staff's recommendation, and the applicable statutes and rules. The Commission finds Evergy's request for a waiver of Commission Rule 20 CSR 4240-3.155(3) reasonable and will grant it. The Commission finds the tariff sheets comply with Commission Rule 20 CSR 4240-3.155 and will approve them.

The Commission finds it reasonable to make this order effective in fewer than 30 days to allow the tariff sheets to go into effect on the requested date.

THE COMMISSION ORDERS THAT:

- 1. Evergy's request for a waiver of Commission Rule 20 CSR 4240-3.155(3) is granted.
- 2. Evergy Missouri Metro's tariff sheet submitted on January 22, 2025, as substituted on January 31, 2025, and assigned Tracking No. JE-2025-0116, is approved to become effective on February 21, 2025, as follows:
