**ORDER DIRECTING COMPLAINANTS TO SHOW CAUSE
WHY COMPLAINT SHOULD NOT BE DISMISSED**

Issue Date: January 16, 2025

On December 18, 2024, the Commission issued an order setting a procedural conference in this matter for January 15, at 10:00 a.m., to be conducted via WebEx telephone and video conference. Counsel for Union Electric Company d/b/a Ameren Missouri and counsel for the Staff of the Commission appeared for the procedural conference at the scheduled date and time. Complainant Ryan Dooley did not appear.

Per Commission Rule 20 CSR 4240-2.090(5), "Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint . . . unless good cause for the failure to appear is shown." The Commission will order the Complainant to file a pleading showing cause as to why his complaint should not be dismissed.

THE COMMISSION ORDERS THAT:

1. Complainant Ryan Dooley shall file a pleading no later than January 31, 2025, showing cause why his complaint against Ameren Missouri should not be dismissed for failure to appear for the scheduled prehearing conference.

2. This order is effective when issued.

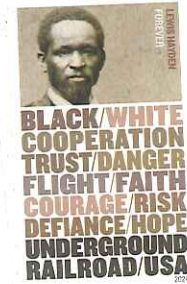
